**Contractor License Fee Structure
Effective January 1, 2018**

Companies and individuals doing business with the Pueblo of Laguna or Laguna Development Corporation related to gaming must be licensed if they do, or anticipate doing, more than \$10,000 of business in a calendar year. Those licenses fall into three categories: gaming, non-gaming, and construction.

- Applicants that reasonably anticipate receipts to equal or exceed \$10,000 in the calendar year will use the descriptions below to determine which license category to apply for, complete the appropriate application, and remit a check or guaranteed form of payment for the full amount.
- Applicants that reasonably do **not** anticipate receipts to equal or exceed \$10,000 in a calendar year are nevertheless required to remit a Non-Refundable Pre-License Screening fee of \$100.00 upon and the pre-license screening authorization. **If receipts in fact equal or exceed \$10,000, the applicable license and license fee will be required.**

Regardless of the anticipated receipts, each individual that falls within the “Contractor Technicians” description below requires a license and must submit a Contractor Technician Application with the appropriate fees.

Gaming

LGCB 104(v); 1004(d)(1) - Any Person providing goods or services under a Gaming-Related Contract, including individual Persons who both are employed or retained by the Gaming-Related Contractor who will have access by any means to Gaming Machines, Gaming Equipment, Gaming Systems, Gaming Revenues, or areas of a Gaming Facility deemed sensitive by the Tribal Gaming Regulatory Authority (“TGRA”), or to sensitive information regarding any of the aforementioned.

Non-Gaming

LGCB 104(jj); 1004(d)(2) - Any Person providing any goods, services, or concessions which are not directly related to a Gaming Activity but which are for use or consumption by a Gaming Operation, Gaming Facility, or significantly by patrons of a Gaming Facility.

Construction

LGCB 1004(d)(3) - Any Person providing construction services to the Pueblo or to a Gaming Enterprise, or Gaming Operation, which are not directly related to a Gaming Activity but which are for use or consumption by a Gaming Operation, at a Gaming Facility, or significantly by patrons of a Gaming Facility.

Please Note: It is the responsibility of the contractor to provide a list of each sub-contractor(s) with the information below to ensure the sub-contractor(s) are properly licensed by the TGRA.

LGCB 104(v); 104(jj); 1004(d)(1); 1004(d)(2) - Any Person providing goods or services under a Gaming-Related or Non-Gaming related Contract, including individual Persons who both are employed or retained by the Gaming-Related or Non-Gaming related Contractor who will have access by any means to Gaming Machines, Gaming Equipment, Gaming Systems, Gaming Revenues, or areas of a Gaming Facility deemed sensitive by the Tribal Gaming Regulatory Authority (“TGRA”), or to sensitive information regarding any of the aforementioned.
